A) MCCA/Risk Pool Update.

County Commissioner Norman L. Fournier reported that at the March Risk Pool meeting: there were 10 claims set up resulting in an increase of \$152,000.00 in reserves; a letter from Attorney Peter Marchesi was discussed commending Captain Craig Clossey for his cooperation on a current claim; the risk pool is currently doing well financially.

County Commissioner Norman L. Fournier reported that at the March MCCA meeting: there was a lot of discussion regarding two legislative bills – LD 973, "An Act To Stabilize County Corrections", and LD 657, "An Act To Reorganize the Probate Courts"; a discussion was held regarding the FEMA audit for Cumberland County; funding was

approved for the "Pirate Program" for the state of Maine Bicentennial – the County will be responsible to select four students to attend; \$1,000.00 was approved for the Criminal Justice Committee members and possibly the Appropriations Committee members to visit select county jails to view conditions.

A) Dispatch Service Agreements.

County Administrator Ryan D. Pelletier presented Dispatch Service Agreements for the towns of Van Buren, Hodgdon, Monticello, St. Agatha, Bridgewater, Littleton, Easton and Haynesville.

County Administrator Ryan D. The Maine State Archives expressed an interest in taking the collection and would work on digitalizing it. The Fort Fairfield Library also expressed an interest and would also work on getting the collection digitalized. The University of Maine at Presque Isle would take the collection, digitalize it and would offer it digitally to other County libraries. The County Administrator favors the University of Maine's proposal and has asked that the University submit a formal presentation to be discussed at a future County Commissioners' meeting.

C) MDOT Construction over-limit permit for Benedicta TWP.

County Commissioner Fournier asked that the County Administrator work with the EMA Director to find a way to suitably recognize the individual at a future Commissioners' meeting.

AROOSTOOK COUNTY VOTES TO BE ADOPTED

Voted:

That the Board of Commissioners of Aroostook County (the "County") hereby authorizes a borrowing in anticipation of tax receipts for the 2019 fiscal year in the original principal amount not to exceed Two Million Three Hundred Thousand Dollars (\$2,300,000) from Katahdin Trust Company on behalf of the County with interest thereon at 3.25% per annum.

Voted:

That under and pursuant to the provisions of Title 30-A M.R.S.A. Section 932 and Article III, Section 8(p) of the Charter of the County of Aroostook the Board of Commissioners and the Treasurer of the County be and they are hereby authorized to borrow in anticipation of tax receipts from Katahdin Trust Company in the name of the County the sum of up to Two Million Three Hundred Thousand Dollars (\$2,300,000) at the interest rate of 3.25%; and that the Board of Commissioners and the Treasurer be and they are hereby authorized to issue general obligation securities of the County in an aggregate principal amount not to exceed Two Million Three Hundred Thousand Dollars (\$2,300,000) and toexecute and deliver a note or notes under the seal of the County attested by the County Administrator, dated on or about March 29, 2019 in such form as the Board of Commissioners and Treasurer may approve; and that the appropriate officials of the County be and hereby are authorized to execute and deliver on behalf of the County such documents and certificates as may be required in connection with such borrowing; and that no part of the proceeds of said borrowing shall be used, directly or indirectly, to acquire any securities and obligations, the acquisition of which would cause the notes to be "arbitrage bonds" or "private activity bonds" within the meaning of Sections 148 and 141, respectively, of the Internal Revenue Code of 1986, as amended (the "Code"); and that the notes be designated as qualified tax-exempt obligations within the meaning of Section 265(b)(3) of said Code; and that the Board of Commissioners and the Treasurer be and they are hereby authorized to covenant on behalf of the County to file any information report and pay any rebate due to the United States in connection with the issuance of the notes, to take all other lawful actions necessary to ensure the interest on the notes will be excluded from gross income of the owners thereof for purposes of federal income taxation and to refrain from taking any action which would cause interest on the notes to become includable in the gross income of the owners thereof.
